PUBLIC COMMENTS

Jeff Gier, Sewer Manager stated that the new home on Lake Shore Drive is hooked up to the sewer and working.

Bob Godfrey, Road Commissioner reported that the budget for 2011 does not include new equipment or asphalt, but will include for budget 2011, matching funds on gravel patching and snow removal. Bob commented that the culvert project on Seely Road turned out nice.

Brad Benzing, County Commissioner Representative shared info on several topics, which included: Poverty levels for families, Medical Care Facility, Farm Market, (their successful conclusion) Central Dispatch, Planning Ordinance for County Commissioners, Finalizing the money for fire department and Ambulance Association for the coming year.

Sharon Zimmerman asked that the board add to their list of bills submitted, Check #8907 – Hillsdale County Clerk for elections, \$208.81 and check # 8908 – Kansas City Life, for dental insurance, \$164.

Harold Douglas asked to add caller ID onto his township phone bill, Fred told him that it was ok to do.

Motion was made by William White and supported by Harold Douglas to pay all General Fund Bills. The motion unanimously passed.

Motion was made by William White and supported by Roger Zimmerman to pay all Sewer Fund Bill. The motion unanimously passed.

Motion was made by Sharon Zimmerman and supported by Harold Douglas to adjourn. The motion unanimously passed.
