CALL TO ORDER

The monthly business meeting was called to order by Supervisor, Brad Smith. The Pledge of Allegiance was recited. Board members present were Brad Smith, Heather Stump, Sam Brown, and Betty Burkhart. Roger Pitts was absent.

MINUTES

The board approved the August 11, 2010 minutes. Sam Brown made the motion and Heather Stump supported the motion.

SYSTEMS and SEWER REPORT

Rick Mahoney reported that the ponds are clean. Discharge of Merry Lake will begin on October 1, 2010. Lake Diane discharge will begin the third week of October.

John Mason reported that the preventative maintenance was complete. Lake Diane and Merry Lake have had weed control. John is planning to do another check on the old barn restaurant sewer (septic) system.

SUPERVISOR UPDATES

Brad Smith reported that Randy Wilcox got the bid for the Lake Diane well project. We need to contact Randy for a start date.

Brad Smith reported 3rd easement on Merry Lake sewer project is almost ready to be recorded. We are still waiting for the MDNRE to grant us a construction permit. It is approximately 30 days away.

Brad Smith will be preparing a letter to Nick Wheeler at the Land Equalization Office. The letter question if the sewer rates on the empty lots at the lakes have been eliminated. Brad will bring letter to October board meeting.
