

NOTICE OF HEARING ON REVISED SPECIAL ASSESSMENT ROLL  
FOR THE LIME LAKE/PRATTVILLE SANITARY SEWER IMPROVEMENTS

The Township Board of the Township of Wright has previously determined to acquire and construct sanitary sewer improvements in the Township of Wright and to assess part of the cost thereof to a special assessment district consisting of the following described lands:

Description of Special Assessment District

The Lime Lake/Prattville Sanitary Sewer Improvements Special Assessment District shall consist of all properties near or adjacent to Lime Lake and the unincorporated area of Prattville located on Lime Lake Road, Elm Road, Lake Shore Drive, Zimmerman Road, West Channel Drive, East Channel Drive, Willow Trace, Prattville Road, Coman Road, Young Drive, Lenore Drive, Emens Drive, Kipp Street, and Knox Street, that have the following tax identification (sidwell) numbers:

A public hearing was held on December 9, 2004, at which time all interested persons were given the opportunity to be heard relative to the making of the improvements and to the special assessment district therefor.

As a result of information received at a public hearing held on February 2, 2006, a revised special assessment roll assessing part of the cost of said improvements in the sum of \$1,284,000 to the aforesaid special assessment district has been prepared and filed in the office of the Township Clerk.

PLEASE TAKE NOTICE that a public hearing will be held on Thursday, March 2, 2006, at the Wright/Waldron Municipal Building located at 112 East Center Street, Waldron, Michigan, at 7:30 p.m., at which time any interested person will be given the opportunity to object to the revised special assessment roll as prepared by the Township Supervisor. A person objecting to the revised special assessment roll shall file the objection in writing with the Township Clerk before the close of the hearing or within such further time as the Township Board may grant.

Appearance and protest of the special assessment at the hearing is required in order to appeal the amount of the special assessment to the Michigan Tax Tribunal. An owner of or party in interest in property to be assessed, or his or her agent, may appear in person to protest the special assessment, or may protest the special assessment by letter filed with the Township Clerk at or prior to the time of the hearing, in which case appearance in person is not required. If the special assessment is protested as provided above, the owner or any party having an interest in the real property may file a written appeal of the special assessment with the Michigan Tax Tribunal or other court of competent jurisdiction within 30 days after the confirmation of the special assessment roll.

The plans and cost estimate of the improvements are on file in the office of the Township Clerk for public examination. To arrange for examination of the plans, cost estimate or revised special assessment roll, please contact Township Supervisor Fred Horwath at 517 286-6376.
