

Approved Minutes – Reading Township Board
June 6, 2005, Regular Meeting

Meeting called to order at 6:01 PM with James Galloway, Roger Wheeler, Ron Parker and Judy Wheeler present. Randy Wigent absent. Also present were Township Attorney Kevin Shirk, Hillsdale County Road Commission Engineer-Manager Stan Clingerman and Road Commissioner Bob Godfrey along with 38 people who were residents of Totem Village or otherwise interested in the process of developing a special assessment district. (A list of these attendees is attached) This was a special meeting for the purpose of discussing the possibility of developing a special assessment district at Totem Village to pave the roads within Totem Village.

Supervisor Galloway turned the meeting over to Hillsdale County Road Commission Engineer-Manager Stan Clingerman who presented a detailed cost estimate of the entire project along with some of the reasoning for some of the items. The total estimated cost for this project was \$720,250.

Following this Township Attorney Kevin Shirk described the process of developing a special assessment district along with some of the rules involved in applying special assessments to individual lots. The official beginning of this process would be to collect petition signatures from 51% of the affected lot owners.

Both Stan Clingerman and Kevin Shirk responded to various questions from the Totem Village residents.

Supervisor Galloway adjourned the meeting at 6:35 PM.
