2005 Winter Tax Bills were due February 14, 2006.

2005 Summer Tax Bills were mailed early in July 2005 and were due on September 14, 2005.

As of March 1, 2006, any delinquent 2005 tax bill (Summer or Winter) must be paid to the Hillsdale County Treasurer.

DOG LICENSES can only be issued if official Rabies Vaccination Certificate given by DVM is presented at time application for license is made. The cost was \$15.00 for male or female, \$10.00 if unsexed. **However this cost doubled after Match 1, 2006 and is now \$30.00 for male or female and \$20.00 if unsexed.**

Looking ahead to 2006 Tax Bills – Some more changes are coming:

Due to a change in state law (Public Acts 356 and 357 of 2004), one-third of the county allocated operating millage was **shifted** to the July 2005 property tax bill from the December 2005 property tax bill. Now this year, another one-third of the county allocated operating millage will be **shifted** to the July 2006 property tax bill from the December 2006 property tax bill so that in 2006, 2/3 of the county allocated operating millage will be collected as part of the summer tax, while only the remaining 1/3 will still be collected as part of the winter tax.)

Summer property tax bills will be mailed to all property owners (or their designated agent) on July 1, 2006 and must be paid by September 14, 2006 to avoid being charged interest.

Winter property tax bills will be mailed to all property owners (or their designated agent) on December 1, 2006 and must be paid by February 14, 2007 to avoid being charged interest.
